### Raffle Tickets

#### How much do I have to raise?

Each skater is required to sell a specified amount to support their team needs; the amount varies based on the team.

Skaters must reach their goal of total dollar amount or pay the difference. Skaters are welcome to sell more tickets if desired and can get more tickets if needed. Parents may choose to buy out of this fundraiser if they wish.

## Record Keeping & Ticket Turn In

### How do I record my ticket sales?

There are two record sheets, one for raffle tickets and another for sponsors. You can fill the form out electronically or print it and handwrite on the form. These forms are required at turn-in. The more complete your records, the faster we get you through the turn-in process.

### When is turn-in?

Tickets and sponsorship turn-in will take place the first week of August and the first week of September.

### What do I need to turn-in

Unsold tickets, sold ticket stubs, completed record sheets, and collected money raised. Bonus points, bragging rights, and endless gratitude if you submit a check for all raffle cash collected to simplify the process.
